### PDF Reader Biz Breached: Foxit Forces Password Reset

Customers of popular PDF firm [Foxit Software](#) are being asked to reset their passwords after a data breach at the firm led to unauthorized access.

The developer of the PhantomPDF editor and Foxit Reader PDF reader tools has yet to go fully public with the news and its official Twitter feed remains devoid of any updates. However, affected customers were emailed late last week and told to choose new passwords after the firm reset their log-ins.

“Foxit has detected that unauthorized access to some of its data systems has taken place, including access to its ‘My Account’ user account data. This means that data you have entered on our website when signing up for our services has likely been accessed by hackers,” the firm admitted. [READ MORE](#)

### Hack Exploited Apple Users for Two Years

Researchers from [Google's Project Zero](#) have discovered a threat campaign that operated against users of [Apple](#) iOS devices for two years.

Earlier this year Google's Threat Analysis Group (TAG) discovered that a small collection of hacked websites was being used to carry out indiscriminate watering-hole attacks against visitors, using iPhone zero-day.

Victims were ensnared just by visiting one of the hacked websites, which are estimated to have attracted thousands of visitors per week. This simple action alone was enough to inadvertently trigger an exploit server to attempt to install a monitoring implant on the user's device.

Hackers exploited flaws in iPhone software to stealthily take over a victim's device and access a user's contact info, media files and GPS location, together with data from [Instagram](#), [WhatsApp](#), [Telegram](#) and [Gmail](#). [READ MORE](#)

## Crisis communications lessons from a statement made by the UK National Grid CEO

On August 9th the UK experienced its largest wide-area power outage for over a decade, causing widespread disruption. Following the incident, National Grid CEO John Pettigrew issued a crisis communications statement, which provides some interesting lessons.

The statement is reproduced below with some learning points inserted by Continuity Central’s editor, David Honour.

“There is never a good time for a power cut. But ten to five on a Friday afternoon in August, when people are trying to get home to their families and friends after a hard week at work, is one of the worst.”

**Learning point:** Mr. Pettigrew recognises the extent of the difficulties caused by the incident and attempts to express empathy with those impacted. [READ MORE](#)

## An approach to cyber resiliency: unifying cyber security incident response and business continuity

*Bringing cyber security incident response and business continuity teams together will enable organizations to better manage cyber resiliency suggests Chandrasekar S.*

Cyber risks are nowadays considered as a business risk and not limited to being simply an IT risk. The after-effects of a cyber incident are not only restricted to loss of IT systems but also include other business impacts, such as loss of reputation, loss of transparency and honesty, financial instability and operational losses. In many organizations, the security incident response function, which is the foremost team to manage these kind of events, is aligned within the security department while the business continuity function is owned by business and IT DR is owned by the infrastructure managers. It is high time to integrate these disciplines under a common function called cyber resiliency.

In general, any form of a cyber risk is considered as one of the sub scenarios, or a small part, of the larger business continuity plan of the organization; while the main scenarios for the business continuity plan are more focused on non-availability of a facility or data center/centre due to natural disasters or unavailability of critical systems. ## 8 critical blind-spots in business continuity: Why ignoring them is a risk

Irrespective of size or nature of the business, every enterprise is exposed to ever changing threats that could disrupt its business. According to Forbes report 2019, the top five global risks in terms of likelihood are:

- Extreme weather conditions
- Failure of climate change mitigation and adaptation
- Natural disasters
- Data fraud or theft
- Cyber attacks

In addition, there are several other threats that organisations are exposed to. Technology failures, terrorism, supply chain failures and rapid spread of infectious diseases are some of the high impact emerging threats that organisations should be aware of.

It is a common understanding that the randomness of these harsh or destructive threats is much higher today, than a decade ago. Furthermore, there is also a certain degree of denial that the harsh disruptions will not happen any time soon, and that they can remain 'safe'. Staying in denial is the worst obstacle to tackling the issues and threats. They fail to understand the big picture as they are engrossed in their day-to-day activities. It is often seen that these business leaders down-play the consequences of materialisation of the threat.

However, there are others who think more rationally and with a strategic vision. They attempt to understand the threats and the risks that are associated with them. They take the right action to diminish the impact or measures to reduce the frequency or scale of occurrence. They are committed to continue their business activity. They want to protect their businesses, safeguard their people and assets, when the worst happens.

### Blind spot #1: Relying on the trouble-free past

When things are smooth everyone is happy. It is human nature to think that tomorrow is an extension of today. If today is good, why not tomorrow? History has shown that many business leaders are blindsided by apparent risks around – may be political, natural disasters, people related, cyber threats, etc. There is no preparation for any of the unforeseen events. People are not trained and the senior leadership refuses to accept the evolving threat landscape. They lack the vision to see beyond the obvious and have conveniently grown to be complacent.
