## President’s Comments

ACPNorth Texas,

I recently had a conversation with my undergraduate class on the topic of technology and disasters. We spent time identifying many of the tools available that may help a resiliency professional with their work (i.e. dashboards, mass notification tools, cloud-based incident management software). We focused not on the use, but on how to overcome the barriers for implementation. There are many ACP members who have struggled with adding tools to their resiliency programs for one reason or another. Here are a few observations we discussed.

Obsolescence. Has this ever happened to anyone when car shopping? You carefully research and make the purchase or lease decision on your new car, only for a completely re-designed version to come out 6 months later with additional appealing features at no extra charge. In many ways, our delayed decisions on resiliency tools may render some tools as obsolete when we finally receive the green light to purchase and implement the tool. Systems have a lifecycle and understanding how the system will change over time can influence your adoption decision.

Another pitfall discussed was the limited amount of benefit received to a single business unit, department, or process. All organizations have their own “turf” and boundaries. Technology integration that can overcome some of the organizational boundaries may mean you hear “no” fewer times. Technology solutions that offers you and others from different teams a way to leverage the automation provided can go a long way. If your notification system is integrated with finance to alert of looming deadlines or other transactional benefits. Setting up your task force with members that may receive benefit from the proposed technology can remove the disaster focus and emphasize efficiencies within your operations. With the emphasis lately on information security, perhaps there is some overlap and opportunity with resiliency professionals to team up on technology solutions.

What barriers are you seeing as your review and evaluate new technology solutions? Do you have some lessons learned to share? If so, let’s talk about it during our next chapter meeting.

Lastly, we have a great social event planned for ACP members who are able to attend the ACP Summit at Continuity Insights in April. On Monday April 20<sup>th</sup>, join us for dance lessons, karaoke, games, and BBQ at Cooter Browns Saloon from 6:30pm-10pm (Sponsored by Fusion Risk Management). I hope to see you there.

# What Businesses Can Do In Response To The Coronavirus

The headline-making coronavirus that originated in China continues to spread with nearly 3,000 confirmed cases and 80 deaths across 12 countries according to the World Health Organization. The potential business impacts could be devastating. What should all businesses be doing now? Markets are already falling as the pandemic takes its toll on the global economy. World Bank findings suggest that a pandemic of the same severity as the 1918 influenza pandemic could reduce global GDP by 5%. Another study predicted income losses of over 12% of gross national income worldwide, including losses of over 50% of the gross national incomes of lower-income countries. While there are those companies that are prepared, organizations as a whole are vastly underprepared to respond to a pandemic. Pandemic preparedness programs are chronically understaffed and underbudgeted. Why? Because it's a low probability risk in any given year. Insurance models predict that the annual risk of an influenza outbreak on the scale of the 1918 pandemic lies between 0.5% and 1.0%. The trouble is that while annual probability is low, the potential impact is devastating. Six pandemics in modern history led to excess mortality rates ranging between 0.03% and 0.08% of world population. Today, that would be the equivalent of between 2 million and 6 million deaths globally. That is why quarantines and social distancing policies are now being imposed by governments. As a result of travel bans and other measures, global businesses are already taking a hit Disney closed two theme parks. Starbucks shuttered 90 stores, with KFC, Pizza Hut, an McDonald's following suit. These business, and more, are enacting carefully crafted, complex business continuity plans as well as more specific pandemic preparedness plans that enable them to respond quickly. Many businesses will impose travel restrictions on employees as a precaution, which could have long-ranging implications They will also be relying on business interruption insurance coverage and should check their coverage to confirm that it is sufficient. Legal protection including force majeure clauses, which will likely be triggered here, should also be reviewed at this time. The travel industry is especially impacted as a result of decreased travel during the Chinese Lunar New Year season, which is typically the largest annual migration of people globally. Major hotel chains like IHG, Marriott, and Accor are waiving cancellation fees. Airlines are offering refunds. There could also be a devastating impact on global supply chains if social distancing is mandated requiring factory employees to stay home and not report in to work. What can all businesses do now? Update your pandemic plans. Talk to employees. Hysteria is also contagious. Communicate what your plans could mean for employees including health and risk education, social distancing through work from home where possible, and stockpiling of supplies. Let them know you are prepared and are protecting them. What can everyone do now? Everyone should have a personal plan that includes knowledge of how to prevent the spread of infection and supplies like stockpiles of food water, medicine and hygiene tools like face masks at home. This should be done now before there is a run on supplies (think about those empty shelves before a hurricane). With a focus on preparedness and swift action, we can help lessen the spread of a pandemic and reduce the business as well as the human impact.

## Coronavirus Raises New Business Continuity, Phishing Challenges for InfoSec

What happens when understaffed security teams at home and abroad are sequestered in physical quarantine zones?

Cyberattacks are barraging businesses with phishing lures touting fake info about the Coronavirus. And although the lures may be fake, the security and business continuity threats that some IT departments are preparing for are quite real. One big question: If workers are sequestered in physical quarantine zones, will IT and SecOps be able to continue?

Initially, businesses may dismiss this risk until the virus reaches their regions. However, the risk is more prevalent as the IT supply chain becomes more global and organizations rely on overseas IT services — from help desks to 24/7 SOC-as-a-service. The concern is not just that workers themselves may get infected by the virus; the concern is that employees, contractors, and service providers' workers who are not infected could nevertheless be quarantined for being in physical proximity to the infected individual.

"If you've got 200 workers working in one place and one of them presents themselves with the illness, it's pretty likely the government is going to quarantine everybody," says Edward Minyard, senior consultant at IP Architects, who was an Accenture consultant working with Mexico City on pandemic prevention during the H1N1 virus spread in 2009.

"And the current [quarantine] protocol is for 14 days. So that can have a material impact on folks' planning.

"If you've got a large outsourced facility, for example, for your security management, or any facility with a large number of people in it, you probably don't want to bring 100 people together and put them in a small room unless you yourself have some evidence that they have not been affected. ... And the second part of the challenge is they may not be able to get there. Or even want to go there."

Minyard says his American clients are beginning to consider the secondary impact they may feel if the virus further expands in, for example, India, a source of so many IT services. (Although India shares its northern border with China, it has thus far experienced only three confirmed cases of the virus, according to the World Health Organization, all of which are in Kerala, a western coastal state that does not border China.)

Nevertheless, Indian businesses have reported disruptions because of the stoppages in shipments from China, where over 45,000 confirmed infections and over 1,000 deaths have been reported, and many millions are in quarantine. All the way over in Barcelona, Mobile World Congress — the world's biggest trade show for the mobile phone industry — was canceled just one week before it was set to start.

The same challenges also apply to telecoms, electric companies, "and all the others that maintain the networks that are supposed to be supporting the rest of us," Minyard says.

"From the perspective of business continuity and continuity of operations, this is a real thing," he says. "This is not speculation. This is going on, and we don't know how bad it's going to be. Should you have all your eggs in one basket ... I'd be thinking of a different plan."

IT security departments, already short-staffed, could be stressed even further than most other teams. And that's something about the coronavirus that cyberattacks will surely capitalize on — just as they have already.
